- Full Playing Member - £150** or an active Standing Order for 5 equal payments September to January Inclusive payments in place by **30/09/2021**
A discount of 30% will apply
- Student and Apprentice Playing Member - £100** or an active Standing Order for 5 equal payments September to January inclusive in place by **30/09/2021** **A discount of 30% will apply**
- Colts Playing Member (& if relevant, Ladies Playing Member) - £100** or an active Standing Order for 5 equal payments September to January Inclusive in place by **30/09/2021** **A discount of 30% will apply**
- Full Non-Playing Member (Voting) - £50** or an active Standing Order for 5 equal payments September to January inclusive in place by **30/09/2021**. (No SO)
